- 3) AAOU 2003 Annual Conference

The 17th Annual Conference was successfully hosted by Sukhothai Thammathirat Open University (STOU) from 12 to 14 November 2003 at the Siam City Hotel under the theme 'Networking and Partnership for Strengthening Collaboration in Open and Distance Education'.

The keynote address was delivered by Prof. Wichit Srisa-an (founding President of AAOU, AUAP), Prof. Gajaraj Dhanarajan (President and Chief Executive Officer, The Commonwealth of Learning), Prof. Michael W. Churton (Director of Distance Learning, University of South Florida) and Prof. Paul Bacsich (Director of Special Projects at UK eUniversities).

In addition, a number of pre-conference workshops and a meeting with the President and Secretary-General of the AAOU were also organized. Also there are 73 oral and 5 poster presentation were scheduled. Attendance was satisfactory and participants were able to develop a better understanding on the working of the Association.
