FOREWORD

As the immediate past President of the AAOU, I would like to take this opportunity to express my deepest gratitude and appreciation to all members of the Executive Board and General Body of AAOU for their close cooperation and support over the last three years from 2011 till 2013.

The Association's membership has now grown to more than 65 Full and Associate members including the national open universities of Japan, Korea, China, Indonesia, India, Bangladesh, Malaysia, Pakistan, Philippines, Sri Lanka, Thailand and Vietnam. Current enrolment in AAOU member institutions exceeds 12 million students and many more have graduated over the past several years. The past two decades have seen strong growth in the number of open universities as well as in the number of students they serve. Most significantly, we have also seen impressive improvements in the quality of education delivered through the ODL mode. Most Governments now accept graduates of ODL institutions as 'at par' with those produced by their counterparts using conventional delivery modes. Many employers prefer to hire graduates from ODL institutions as they are characteristically more mature and possess rich working experience.

The AAOU has enabled many Asian ODL communities to foster co-operations and collaborations as well as enhance the development of ODL in the region and globally. It also paves the way for exchange of research findings and experience sharing among the practitioners.

Last but not least, my heartiest congratulations to Prof. John Leong of Open University of Hong Kong who has been elected as the new AAOU President for the period of 2014 to 2016. The Association will certainly continue to progress and reach greater heights under his stewardship. Let me also offer my congratulations to the newly elected AAOU Executive members comprising members from Allama Iqbal Open University, Hanoi Open University, Korea National Open University, Payame Noor University, Universitas Terbuka and The Open University of China

1.0 INTRODUCTION

The end of 2013 recorded another milestone in the history of the Asian Association of Open Universities (AAOU) as the beginning of 2014 would see Prof. John Leong, the President of Open University of Hong Kong assuming the office of AAOU President. Consequent to this the AAOU Secretariat would be relocated to OUHK with Dr. Li Kam Cheong as the Secretary-General.

Collection of membership fees have always been a challenge to the AAOU Secretariat. Invoices are forwarded to all members at the beginning of each year and followed by email reminders by the Secretariat to those who have yet to settle their subscription fees. In year 2013, there was an improvement in the collection of membership fees particularly from the Full Member institutions. Further details are recorded in Item 4 of this report.

This report generally describes the AAOU related activities conducted in 2013 as well as the decisions of the Executive Board and General Body Meetings. This report also incorporates the 27th AAOU Annual Conference 2013 event and some of the actions taken based on the Minutes of the Meetings.

2.0 MEETINGS AND CONFERENCES

2.1 AAOU Annual Meetings of the Executive Board and General Body 2013

The 28th AAOU Annual Meeting of the Executive Board (EB) and the 27th Annual Meeting of the General Body (GB) were held at Allama Iqbal Open University (AIOU), Islamabad, Pakistan on 2nd October, 2013 where AIOU was the host for the 27th AAOU Annual Conference.

Minutes of the EB and GB meetings had been circulated via email to all members for their comments and feedback. Feedback had been received and amendments had been incorporated accordingly. The revised minutes were then forwarded to all members for their retention.



2.2 AAOU Annual Conference 2013

The 27th AAOU Annual Conference was successfully organized by the Allama Iqbal Open University of Pakistan from 1st to 3rd October, 2013 with the theme "Leveraging the Power of Open and Distance Learning (ODL) for Building a Divergent Asia –Today's Solutions and Tomorrow's Vision" (Figure 1 and 2).

This annual conference featured a Keynote Address, 4 plenary speeches, one preconference workshop and parallel sessions where 137 oral presentations were delivered. The Conference deliberations focused on the role of open and distance learning and the need for new developments in the field to find solutions to myriad of problems in catering for diverse societies of the region through ODL. The presentations delivered in the parallel sessions focused on the following conference sub-themes:

- Emerging trends in open and distance learning
- Building a global future through research and innovative practices in ODL
- ODL and human capacity building
- Technologies and strategies for providing education through ODL
- Application of ODL in various disciplines

4.0 AAOU STATEMENT OF ACCOUNTS AND AUDIT REPORT FOR YEAR 2013

According to the audited statement of accounts there was an opening balance of USD 290,569 at the beginning of year 2013. The closing balance as of 31st December, 2013 was USD 309,672 which reflects a net increase of USD 19,103 in the Association's funds. AAOU had granted a subsidy of USD 3,000 to meet a portion of the cost for conducting the 27th AAOU Annual Conference.

The Commonwealth of Learning (COL) and UNESCO Bangkok had provided a grant of CAD5,000 and USD1,000 respectively to cover the registration fees and accommodation subsidy of selected participants attending the 27th AAOU Annual Conference.

5.0 THE AAOU INTER-UNIVERSITY STAFF EXCHANGE FELLOWSHIP PROGRAMME

A Memorandum of Agreement had been signed between the AAOU and Open University of Hong Kong on 19th August 2013.

Both of them had expressed their appreciation to colleagues who have nominated them. In this connection, only Prof. Dr. Nazir Ahmed Sangi from Allama Iqbal Open University and Prof. Dr. John Leong Chi Yan from Open University of Hong Kong contested for the AAOU Presidency.

In the 27th General Body meeting, Prof. Nazir had graciously withdrawn his nomination to make way for OUHK to take on the Presidency. The President thanked AIOU for this magnanimous gestures which clearly reflects the true spirit of AAOU brotherhood and the respect member institutions of AAOU have for each other.

With this Prof. John Leong Chin Yan from the Open University of Hong Kong would serve as the new <u>President of AAOU</u> for the period <u>2014-2016</u> (**Figure 5**). With this succession, the AAOU Secretariat that previously resided in Wawasan Open University would be relocated to the Open University of Hong Kong beginning January 2014.

The AAOU Secretariat had only received one nomination from member institutions to serve on the AAOU Executive Board. The nominations were as follows and represented the regions as stated in the AAOU Constitution:

In this connection, all the above members would automatically serve as the <u>new Executive Board</u> members from 2014 to 2016. As per previous practice, the immediate past president would also serve as a member in the Executive Board.

9.0 PROPOSED AMENDMENTS TO THE AAOU CONSTITUTION

In the 27th AAOU General Body meeting, the following were the approved changes made to the AAOU Constitution (amended version 1999):

The Executive Committee and Administration of the Association will be vested in an Executive Board which will consist of:

i) A President and seven other members, of which one will be the immediate past President of the Association; and not including two coopted members.

iii) The Executive Committee will be so constituted that each of the following regions will be represented: South Asia, South East Asia, China and Far East Asia and West Asia. In the event of any region not being represented on the Executive Committee, the Committee shall co-opt members to effect such representation; in as far as possible the Executive Committee will seek to have representation from all member countries.

v) Co-opt up to two additional members.

vi) Only full members of the Association are eligible to hold office in the Executive <u>Board</u>.

Section 2

The term of office of the Executive <u>Board</u> will be three years, provided that the President, the Secretary-General and two of the members will be eligible to hold the office for a consecutive second term of three years, and provided further that no person shall hold the same office of the Executive <u>Board</u> for more than two consecutive terms.

The term of office of the Executive Committee be three years, provided that the President, the Secretary-General and two of the members will eligible to hold the office for a consecutive secreterm of three years, and provided further that in person shall hold the same office of the Executive term of the Exe

iii) conducting correspondence with members of the Association and outside agencies in accordance with <u>Board</u> policies and in consultation with the Executive Board;

iv) responsibility for all the financial transactions of the Association, maintaining budgetary control and preparing statements of accounts for the Executive Board as requested for presentation to the Annual General Meeting;

vi) providing administrative support to the Executive Committee and carrying out the decisions made by the <u>executive</u> as required.

iii) conducting correspondence with members of the Association and outside agencies in accordance with existing policies and in consultation with the Executive Committee;

iv) responsibility for all the financial transactions of the Association, maintaining budgetary control and preparing statements of accounts for the Executive Committee as requested for presentation to the Annual General Meeting;

vi) providing administrative support to the Executive Committee and carrying out the decisions made by the Executive Head as required.

ARTICLE VIII- Election of the Executive Committee

Section 1

- i) The President and the Executive <u>Board</u> members shall be elected for a period of three years
- vii) The counting of the votes shall be conducted by the Secretary-General, with the ballot papers being opened and counted in the presence of two scrutineers approved by the Executive Board.
- i) The President and the Executive Committee members shall be elected for a period of three years.
- vii) The counting of the votes shall be conducted by the Secretary-General, with the ballot papers being opened and counted in the presence of two scrutineers approved by the Executive Committee.

ARTICLE IX- The President and the President-Elect:

- (d) In the event that an incumbent President is no longer able to continue in office due to resignation, retirement or any other cause, his/her successor (as President of the Association) will be the person who will replace him/her in the member's institution. The successor will assume the role of the Presidency in an acting capacity until the next AGM.
- (d) In the event that an incumbent President is no longer able to continue in office due to resignation, retirement or any other cause, his/her successor (as President of the Association) will be the person who will replace him/her in the member's institution. The successor will assume the role of the Presidency until the next AGM.

ARTICLE XII - Dissolution

The Association may be dissolved by decision of the Meeting of the General Body.

The Secretary-General shall circulate the exact terms of any proposal <u>sent by a member</u> to dissolve the Association by registered letter to every member of the Association not less than 90 days prior to the meeting.

The Secretary-General shall circulate the exact terms of any proposal <u>submitted and supported by at least 20% of the Full members</u> to dissolve the Association by registered letter to every member of the Association not less than 90 days prior to the meeting.



10.0 CONCLUDING REMARKS

Overall, the Year 2013 was a reasonably successful year. The end of 2013 also marks a significant milestone in the history of AAOU where OUHK succeeds WOU in helming the AAOU Presidency for the next three-year term period (2014 – 2016).
