#### 2 Meetings and Conferences


#### 2.1 AAOU ANNUAL MEETINGS OF THE EXECUTIVE COMMITTEE AND GENERAL BODY 2015

The 30th AAOU Annual Meeting of the Executive Committee (EC) was held at the Traders Hotel, Kuala Lumpur, Malaysia on 30 November 2015. The 29th Annual Meeting of the General Body (GB) was held at the Kuala Lumpur Convention Centre, Kuala Lumpur, Malaysia on 1 December 2015. Open University Malaysia (OUM) was the host for the 29th AAOU Annual Conference.

Minutes of the EC and GB meetings in 2014 were circulated via email to all members for their comments and feedback. There was no need to make any amendments or corrections to the minutes.

#### 2.2 AAOU ANNUAL CONFERENCE 2015

The 29th AAOU Annual Conference was organised successfully by Open University Malaysia in Kuala Lumpur, Malaysia from 30 November to 2 December, 2015 on the theme 'New Frontiers in Open and Distance Learning (ODL)'.



The Deputy Minister of Higher Education of Malaysia, YB Datuk Mary Yap Kain Ching, officiated the AAOU 2015 with the AAOU President, Professor Yuk-Shan Wong, and OUM President, Ybhg Professor Emeritus Tan Sri Anuwar Ali.



The 29th AAOU Annual Conference brought together about 250 international and local delegates who came from over 15 different countries. Participants comprised Vice-Chancellors, Rectors, Presidents, scholars, senior administrators and policy-makers representing the open universities in the Asian region and other ODL institutes or organisations. On 30 November 2015, the conference was officiated by the Deputy Minister of Higher Education of Malaysia, YB Datuk Mary Yap Kain Ching.

This annual conference featured five keynote speeches, a Presidents' Forum, and five parallel sessions. The Conference aimed to be a catalyst for knowledge-sharing among participants, particularly in areas related to the following sub-themes:

- New Paradigm for Open Universities
- Technology as Drivers in ODL
- New Research and Practices in ODL
- Quality Assurance in ODL
- Open Knowledge Movement.

# 4 AAOU STATEMENT OF ACCOUNTS AND AUDIT REPORT FOR YEAR 2015

According to the audited statement of accounts, there was an opening balance of USD340,508 at the beginning of the year 2015. The closing balance as of 31st December 2015 was USD355,553 which reflects a net increase of USD15,045 in the Association's funds. AAOU granted a subsidy of USD3,000 to meet a portion of the cost for conducting the 29th AAOU Annual Conference.

The Commonwealth of Learning (COL) provided a grant of USD3,620 to cover the registration fees and accommodation subsidy of selected participants attending the 29th AAOU Annual Conference.

#### 5 THE AAOU INTER-UNIVERSITY STAFF EXCHANGE FELLOWSHIP PROGRAMME

The AAOU Inter-University Staff Exchange Fellowship Programme aims to provide a platform for capacity-building and the establishment of sustainable partnerships, as well as fostering the exchange of knowledge and promotion of mutual understanding among staff of Asian open universities.

### 7 THE 30TH AAOU ANNUAL CONFERENCE IN 2016

In December 2014 and June 2015, the AAOU Secretariat invited the Full Members to consider hosting the 30th AAOU Annual Conference in 2016. By September 2015, only one proposal was received, submitted by University of the Philippines Open University (UPOU).

The Proposal was circulated to Executive Committee members via email on 11 September for comments and approval. UPOU was approved as the host for the 2016 AAOU Annual Conference. Subsequently, a Memorandum of Agreement was signed between the AAOU and UPOU.

#### 8 Proposed Amendments to the AAOU Constitution

In the 29th AAOU General Body meeting, the following change was approved to be made to the AAOU Constitution in Article VIII, Section 1 (amended version 2015):

(iii) All candidates for the Executive Committee must have been a full member for the last three consecutive years, with membership payment fully settled.

## 9 Publishing Electronic Newsletters

The President and Secretariat are keen to enhance communication among AAOU members and update them on the latest events and developments at member institutions in order to bring the most recent information directly to scholars and professionals. The AAOU continued to publish AAOU News and the eBulletin which were first published in 2014. In 2015, one issue of AAOU News and five issues of the eBulletin were published. In these e-communications, important events, such as international conferences on open and distance education, the offering of the Inter-University Staff Exchange Fellowship Programme by our member institutions, and the publication of the AAOU Journal were announced, and calls for paper submission and updated news from member institutions were delivered.
