#### 1 Introduction

The end of 2016 recorded another milestone in the history of the Asian Association of Open Universities (AAOU) as the beginning of 2017 will see Professor Melinda Bandalaria, the President of the University of the Philippines Open University (UPOU) assuming the office of the AAOU President. The AAOU Secretariat will be relocated to the UPOU with Professor Grace Alfonso as the Secretary-General.

This report offers an account of the activities of the AAOU conducted in 2016, as well as the decisions of the Executive Committee and General Body Meetings. It also incorporates the 30th AAOU Annual Conference 2016 event and some of the actions taken based on the Minutes of the Meetings.

#### 2 MEETINGS AND CONFERENCES

#### 2.1 AAOU Annual Meetings of the Executive Committee and General Body 2016

The 31st AAOU Annual Meeting of the Executive Committee (EC) and the 30th Annual Meeting of the General Body (GB) were held on 26 October 2016 and 27 October 2016 respectively in Crowne Plaza Manila Galleria, Metro Manila, the Philippines. The University of the Philippines Open University (UPOU) was the host for the 30th AAOU Annual Conference.

Minutes of the EC and GB meetings in 2015 were circulated via email to all members for their comments and feedback. There was no need to make any amendments or corrections to the minutes.

#### 2.2 AAOU ANNUAL CONFERENCE 2016

The 30th AAOU Annual Conference was hosted successfully by the University of the Philippines Open University in Metro Manila, the Philippines from 26 to 29 October, 2016 on the theme 'Open Education in Asia: Changing Perspectives'.

The 30th AAOU Annual Conference brought together about 500 delegates who came from over 15 different countries. The participants comprised Vice-Chancellors, Rectors, Presidents, scholars, senior administrators and policy-makers representing the open universities in the Asian region and other ODL institutes or organisations. On 26 October 2016, the conference was officiated by Dr Gisela Concepcion, Vice President for Academic Affairs, University of the Philippines; Professor Yuk-Shan Wong, President, Asian Association of the Open Universities; Dr Amelia A. Biglete, Director IV of the Office of Programs and Standards Development, the Commission on Higher Education of the Philippines; and Professor Melinda dP. Bandalaria, Chancellor, University of the Philippines Open University.

The AAOU 2016 featured two pre-conference seminars, four plenary sessions and five parallel sessions. The Conference aimed to bring together Asian ODL advocates, academics, administrators, policy-makers, practitioners, scholars and students to share experiences in open education and critical reflections on the region's contribution to the achievement of "a world of open, flexible and effective education for all", with focused discussions on the following sub-themes:

- Academic leadership in open and distance e-learning (ODeL)
- Open educational practices, open pedagogies
- Open educational resources (OER) and open online courses (including MOOCs)
- Digital and new media literacies
- Assessment of learning in ODeL
- Learning spaces and technologies in ODeL
- Learning analytics and learner support in ODeL
- Quality assurance in ODeL.

#### 2.3 AAOU AWARDS AND THE WINNERS

#### 4 AAOU STATEMENT OF ACCOUNTS AND AUDIT REPORT FOR YEAR 2016

According to the audited statement of accounts, the cash and cash equivalents at the beginning of the year 2016 was USD355,553 and the cash and cash equivalents as of 31 December 2016 was USD363,730. AAOU granted a subsidy of USD3,000 to meet a portion of the cost for conducting the 30th AAOU Annual Conference.

The Commonwealth of Learning (COL) provided a grant of USD3,859 to cover the registration fees and accommodation subsidy of selected participants attending the 30th AAOU Annual Conference.

#### 5 The AAOU Inter-University Staff Exchange Fellowship Programme

The AAOU Inter-University Staff Exchange Fellowship Programme aims to provide a platform for capacity-building and the establishment of sustainable partnerships, as well as fostering the exchange of knowledge and promotion of mutual understanding among staff of Asian open universities.

In 2016, the following four institutions offered fellowships to deserving candidates in the AAOU Inter-University Exchange Fellowship Programme:

- 1. Shanghai Open University, China
- 2. Sukhothai Thammathirat Open University, Thailand
- 3. Korea National Open University, South Korea
- 4. Universitas Terbuka, Indonesia.

It was reported that only two successful applications were identified for each round of the Shanghai Open University fellowships. For the Universitas Terbuka fellowship, only one applicant had a research topic in line with the interest of the donor institution, and was offered the fellowship. As for the Sukhothai Thammathirat Open University fellowship, no successful application was identified. # 7 THE 31ST AAOU ANNUAL CONFERENCE IN 2017

In the Executive Committee meeting in 2015, it was resolved that the host for the AAOU 2017 would be Universitas Terbuka. A Memorandum of Agreement was signed between the AAOU and UPOU on 20 January 2016.

# 8 AAOU Presidency 2017–2019: Nominations and Elections

By the deadline of nomination, there was only one Presidency nominee. Two institutions put forward the same nominee, the University of the Philippines Open University (UPOU), to be the next President of the Association. Also, the following institutions were nominated by two institutions to be Executive Committee members for the term 2017–2019:

The General Body unanimously approved the nominations and the next term of the AAOU Presidency and Executive Committee was formed accordingly. Professor Melinda Bandalaria from the UPOU will serve as the new President of the AAOU for the term 2017 to 2019. With this succession, the AAOU Secretariat that was previously resided in the OUHK will be relocated to the UPOU in January 2017. As in previous practice, the immediate past president, the Open University of Hong Kong, would also serve as a member of the Executive Committee.

#### 9 Proposed Amendments to the AAOU Constitution

In the 30th AAOU General Body meeting, an amendment to the AAOU Constitution was approved. Individual Membership will be granted by invitation or recommendation to distinguished individuals in the ODL field, rather than by application. The Individual Membership is an Honorary Membership. The relevant amendment has been made in the Constitution after the meeting, as follows.
