# 3 MEETINGS AND CONFERENCES

# 3.1 AAOU Annual Meetings of the Executive Committee and General Body 2019

The 34th AAOU Annual Meeting of the Executive Committee (EC) and the 33rd Annual Meeting of the General Body (GB) were held on 14 October 2019 and 15 October 2019 respectively in the Pearl Continental Hotel, Lahore, Pakistan. The Virtual University of Pakistan was the host for the 33rd AAOU Annual Conference.

Minutes of the EC and GB meetings in 2018 were circulated via email to all members for their comments and feedback. There was no need to make any amendments or corrections to the minutes.

# 3.2 AAOU Annual Conference 2019

The 33rd AAOU Annual Conference was hosted successfully by The Virtual University of Pakistan (VUP)

in Lahore, Pakistan from 14 to 16 October 2019 with the theme 'Open Distance Learning: 2020 and Beyond'.

The 33rd AAOU Annual Conference brought together about 600 delegates who came from over 13 different countries. The participants comprised Presidents, Rectors, Chancellors, Vice Chancellors, scholars, senior administrators, and policy-makers representing the open universities in the Asian Region and other ODL institutions and organizations. The conference was officiated by Prof. Masroor Ellahi Babar, Conference Chair; Dr. Nasir Naveed, Conference co-chair; Mr. Naeem Tariq, Rector of VUP; and Dr. Melinda dP. Bandalaria, AAOU President and Chancellor of the University of the Philippines Open University (UPOU). The inaugural ceremony featured Chief Guest, Dr. Khalid Maqbool Saddiqui, Federal Minister for IT and Telecom, and Dr. Bandalaria who delivered a keynote speech on "Attaining SDGs through ODL."

The AAOU 2019 Conference program featured 10 keynote speeches, four plenary panels, five parallel sessions, and two special sessions. The Conference aimed to bring together Asian ODL advocates, academics, administrators, policy-makers, practitioners, scholars, and students in an event that provides a focal point for bringing everyone up to date on the issues, ideas, and developments in the field of open distance learning, with focused discussions on the following sub-themes:

- Next Generation Education Technologies/ Innovations
- Ensuring and Enhancing Quality
- Lifelong Learning: Addressing Personal, Professional and Societal Development
- Challenges for Policymakers and Education Providers
- Social Sciences and Humanities: New Challenges, New Horizons

# 4 MEMBERSHIP

# 4.1 Termination of Membership

The AAOU Secretariat received two requests for AAOU membership termination from Charles Sturt Open University, and Uttarakhand Open University. The two membership termination requests were approved by the Executive Committee and noted by the General Body.

# 4.2 New Membership Applications

The Executive Committee approved two applications submitted in 2019. The details and status of the approval are shown in the following table:

The Executive Committee decided that SEAMEO INNOTECH and Manipur International University would receive full membership.

# 4.3 Two Proposals from the Executive Committee

# 4.3.1 Increase in AAOU membership fee effective 2021

This proposal considers the need for the members to look into the various activities that would be beneficial to members and to enable the Association to have more activities and propose more programs for AAOU in addition to the existing AAOU initiatives and programs. The additional funds from membership fee will also be beneficial to the AAOU Annual Conferences.

Dr. Mansoor noted that the AAOU cash flow indicates that the Association have enough fund thus he argues that there is no reason for the Association to increase the membership fee. He then suggests to maintain the membership fee at USD 600 for Full Members and USD 400 for Associate Members.

The President then noted that the AAOU maintains a healthy financial standing over the years and attributes it to the continuous campaign for membership fee payment among members. She also pointed out that if the Association plans to increase activities and programs in the coming years that would benefit the members, then increasing membership fee is something worth considering. The President also remarks the duration of time of which the membership fee has been at USD 600 for Full Members and USD 400 for Associate Members for a long time, considering the inflation rate, etc. which is the main argument for increasing the membership fee.

Mr. Naeem Tariq added that the expenditure and income for the years 2018 and 2019 are almost the same, thus in order to maintain an upward trend, a slight increase in the revenue can be beneficial to the Association. He also mentioned that even ICDE and other bodies are charging USD 3000 to USD 4000 annually.

Dr. Zia Ul-Qayyum also called the attention of the General Body to the importance of having more members of the Association than increasing the membership fee. He suggests that it would be best to

have another General Body meeting before the proposal of increasing membership fee takes effect in 2021. Although a USD 100 increase in membership fee will not hamper the balance statements of the institutions, Dr. Ul-Qayyum suggests that deferring the decision regarding the proposal to the next General Body Meeting will give the AAOU Executive Committee enough time to present worth value of being a member of the AAOU. Holding the meeting is important to discuss ideas and exchange views, however, Dr. Ul-Qayyum argues that as an association, such meetings would require funds. He then suggests to propose more ideas how the member institutions could really work on the improvement of distance education across the member states while standardizing education standards and working on policies etc. Dr. Ul-Qayyum concludes that once the AAOU members see the value of being members of AAOU, most probably the members would be happily pay for the membership fee. Thus, he further suggests that the Executive Committee should prepare a roadmap for the Association for the next two or three years. He also put forward the possibility of raising funds from alternative means since he believes that any association cannot really be maintained solely through the membership fee.

The President then acknowledge the addition proposal raised by Dr. UI-Qayyum which is to defer the decision on the proposal to increase membership fee for next year's General Body meeting. She then opened voting for the deferment of the proposal. All members were in favor of deferring the proposal to the next General Body meeting in 2020.

The President noted the decision of the General Body and assured the Body that the proposal will be included in the Agenda of the next General Body meeting in 2020.

# 4.3.1 50% discount in the first year of membership to attract new members effective 2020

The proposal aims to increase the level of interest of non-members of AAOU and encourage them to apply for membership. The President opened the floor for suggestions from the Body.

Dr. Mansoor believes that the 50% discount to the membership fee is a bit too much, thus he suggests to give non-members a 5 to 10% discount instead. Dr. Ul-Qayyum believes otherwise, he suggests that the Association should either give no discount at all, or, if AAOU resorts to give discount for membership fee, then the Association must give a respectable amount of discount to non-member since a 5 to 10% discount only amounts to approximately USD 50.

The President then opened the voting for the decision to the second proposal. All members of the General Body are in favor of the proposal to give 50% discount in the first year of membership to encourage new membership effective 2020. The proposal is approved by the General Body and is effective in 2020.

# 5 AAOU STATEMENT OF ACCOUNTS AND AUDIT REPORT FOR YEAR 2019

According to the audited statement of accounts, the cash and cash equivalents at the beginning of the year 2019 was USD and the cash and cash equivalents as of 31 December 2019 was USD. AAOU granted a subsidy of USD3,000 to meet a portion of the cost for conducting the 32nd AAOU Annual Conference.

The Commonwealth of Learning (COL) provided a grant of CAD5,000 to cover the registration fees and accommodation subsidy of selected participants attending the 32nd AAOU Annual Conference.

# 6 THE AAOU INTER-UNIVERSITY STAFF EXCHANGE FELLOWSHIP PROGRAMME

The AAOU Inter-University Staff Exchange Fellowship Programme aims to provide a platform for capacity-building and the establishment of sustainable partnerships, as well as fostering the exchange of knowledge and promotion of mutual understanding among staff of Asian open universities.

In 2019, the following four institutions offered fellowships to deserving candidates in the AAOU Inter-University Exchange Fellowship Programme:

- 1. Korea National Open University (KNOU), Korea (2 slots)
- 2. National Open University (NOU) Taiwan, Taiwan (2 slots, 1 successful application)
- 3. Sukhothai Thammathirat Open University (STOU), Thailand (1 slot)
- 4. Open University of Sri Lanka (OUSL), Sri Lanka (2 slots, 2 successful applications)
- 5. Shanghai Open University (SOU), China (15 slots, 14 successful applications)
- 6. Universitas Terbuka (UT), Indonesia (2 slots, 2 successful applications)
- 7. University of the Philippines Open University (UPOU), Philippines (3 slots, 2 successful applications)

It was reported that the Secretariat is yet to receive the information regarding the Inter-University Staff Exchange Fellowship Program from KNOU. For STOU, the selected applicant was unable to attend the Inter-University Staff Exchange Fellowship Program (1-15 May 2019).

# 7.3 Indexing

The President also reported that the Asian Association of Open Universities Journal has been indexed in:

- British Library;
- Cabell's Directories; and
- Directory of Open Access Journals (DOAJ).

In particular, the journal has been awarded the "DOAJ Seal", indicating that the journal has satisfied the requirements of having a clear commitment to open access best practices, of high levels of commitment to publishing standards and best practices, and its open access model is the most open.

The President also shared the following strategies done by the Secretariat to further increase downloads/traffic in the AAOU Journal site.

- Promotion of the AAOU Journal via the AAOU eBulletin and AAOU Open Calls which were sent via email to all AAOU members. Open calls and promotions of AAOU Journal released via emails are presented in
- Promotion of the AAOU Journal via the UPOU online social media accounts (i.e. Facebook page and Twitter account). Every week, a featured abstract of each paper is posted on social media that links to the full paper of each abstract.
- Proposal for the Allocation of Funds for the AAOU Conference Fellowship to Senior Authors/One of the authors of each of the papers published in the AAOU Journal (AAOUJ) amounting to US6,000 per year starting the 2019 AAOU Conference were circulated and approved by the Executive Committee.
- The full journal is accessible through the AAOU website.

The President assured that the Editorial Team will keep working on getting the journal more widely indexed. The level of success that the AAOU will achieve also depends on the number of quality articles submitted to the journal.

# 8 THE 33RD AAOU ANNUAL CONFERENCE IN 2021

The AAOU Secretariat issued the Call for Proposal for hosting the 35th AAOU Annual Conference in 2021 in March 2019. The call has been made using all possible platforms: AAOU Website; email blasts; AAOU eBulletin; and personal conversations with some AAOU member institutions. The deadline has been extended as well from 30 June 2019 to 15 September 2019. One member had shown initial interest to submit a bid, however, the full proposal was not received by the AAOU Secretariat despite follow-ups.

Given this, the President announced that the hosting for the 35th AAOU Annual Conference (2021) is still open. The AAOU Secretariat will continue to campaign among AAOU member institutions.

# 9 E-COMMUNICATIONS AND ANNOUNCEMENTS

The President and Secretariat are keen to enhance communication among AAOU members and update them on the latest events and developments at member institutions, as well as provide updated news about the AAOU and ODL field, in order to bring the most recent information directly to scholars and professionals. In 2019, six issues of the eBulletin were published, and email announcements were delivered. In these e-communications, important events — such as international conferences on open and distance education, the offering of the Inter-University Staff Exchange Fellowship Programme by our member institutions, and the publication of the AAOU Journal — were announced. Also, calls for paper submission, award nomination, and updated news from member institutions were delivered.

# 10 AAOU INITIATIVES

# 10.1 ASIAN MOOCs

The President, member of the Asian MOOCs Steering Committee, reported to the General Body the activities done in 2019 as follows:

- Continued the call for offering of MOOCs and harvest of data from other LMS of AAOU member institutions
- Continued the promotion of Asian MOOCs and Asian Learning Portal websites to AAOU members.
- Created a Facebook Page to promote ASIAN MOOCs and connect the institutions
- Continued developing courses for the Asian Learning Portal websites
- Continued the pilot run of Open Badge Version 2 (OBv2) of IMS Global for implementation in the Asia Learning Portal Moodle site (UPOU and OUJ)

The President also presented the Asian MOOCs Learning Portal that serves as the official LMS of the ASIAN Languages Massive Open Online Courses (MOOCs) from member institutions of the Asian Association of Open Universities (AAOU). (Nihongo; Korean; English – on going); Thai, Vietnamese; Bahasa (completed). The Asian Languages MOOCs has a total of 2,017 registered users.

The remaining savings from 2019 amounting to USD 7,172.28 will be used to fund the proposed activities for 2020. The proposed activities are as follows:

- Maintain the Asian MOOCs Portal and continue to campaign for MOOCs offering from AAOU
   Members and MOOCs enrollment
- Evaluate the MOOCs based on AAOU MOOCs QA Framework
- Provide guidelines to AAOU members on MOOCs development (AAOU MOOCs QA)
- Repository of Asian OERs
- Develop MOOCs Certification Programs using MOOCs offered by AAOU members and apply the Open badge system

In 2018, an additional budget of USD3,000 on top of the savings of USD5,000 from the previously approved budget for 2018 (amounting to a total working budget of USD8,000 for personnel, hosting, and meetings/workshops/travel arrangement fees) was proposed by the Asian MOOCs Steering Committee and was approved by the Executive Committee. In 2019, there was a total budget of US\$9,555.31 (1,555.31 Savings from 2018 + 8,000,000 (Approved budget for 2019). As of 30 September 2019, a total of USD 2,888.30 was spent for meetings/workshops/travel arrangement fees.

The remaining savings from 2019 amounting to USD 7,172.28 will be used to fund the proposed activities for 2020. The proposed activities are as follows:

- Maintain the Asian MOOCs Portal and continue to campaign for MOOCs offering from AAOU
   Members and MOOCs enrollment
- Evaluate the MOOCs based on AAOU MOOCs QA Framework
- Provide guidelines to AAOU members on MOOCs development (AAOU MOOCs QA)
- Repository of Asian OERs
- Develop MOOCs Certification Programs using MOOCs offered by AAOU members and apply the Open badge system

The General Body noted the decision of the Executive Committee to approve the proposed budget by the Asian MOOCs Steering Committee.

The President also thanked the host institutions for the meetings conducted for the project, as this was the reason for the savings from the previously approved budget.

# 10.2 REPORT OF THE PROPOSED OPEN EDUCATION ACCREDITATION SERVICES

Dr. Grace Javier Alfonso presented to the General Body the progress report of the Phase II of the Accreditation System for Quality Assurance of Technology Mediated Education in Times of Openness in the Digital Age that aimed to develop an accreditation instrument for institutional level accreditation. After a series of virtual and face-to-face meetings, and the workshop in Surabaya, Indonesia last 3 July 2019 with the Accreditation Task Force and Expanded Task Force composed of Quality Assurance and Accreditation experts, an accreditation instrument for institutional level AAOU Annual Report 2018 | 28

accreditation was developed. The experts invited in the workshops are Prof. Dr. Alyssa Alampay (UP Assistant Vice President for Q.A.), Dir. Dr. Mary Sylvette Gunigundo (OIC, Director IV, OPS of Commission on Higher Education, Philippines), Dr. Ir. Kristanti Ambar Puspitasari (Head of the Education Quality Assurance Center at LPPMP-UT), and Prof. Dr. Paulina Pannen (Ministry of Research, Technology and Higher Education of Indonesia). The following were also accomplished by the Expanded Task Force:

- Discussed the Accreditation Framework
- Identified Accreditation Parameters
- Worked together in developing the Proposed Instrument and Accreditation Process
- Discussed the Proposed Schedule for the Phase III

The third phase of the study, along with an additional budget of USD 6000 on top of the savings from 2019 (USD9,971.68), was proposed by the Task Force. The General Body noted the Executive Committee's approval of the budget proposal.

The President also thanked the host institutions for the meetings conducted for the project, as this was the reason for the savings from the previously approved budget.

# 10.3 AAOU COLLABORATIVE RESEARCH PROGRAM

The President reported that with the approval of the Proposal to Establish the AAOU Collaborative Research Program with Funding Allocation of USD18,000 for 2019, the next steps for the AAOU Collaborative Research Program were done starting with the creation of review committee. The review committee finalized the evaluation criteria, evaluation instrument, and evaluated the proposals submitted for consideration for the program.

Two proposals were received and evaluated by the review committee. The President reported that the proponents were informed of the reviewers' evaluation and are now revising based on comments.

# 10.4 PROPOSAL FOR TWO PROJECTS INITIATED BY UNIVERSITAS TERBUKA

Dr. Rahmat Budiman presented to the General Body the updates of the two AAOU initiatives, namely:

- Writing a book on distance education in Asia
- Collaboration to develop post-graduate degree programs to be undertaken by AAOU member institutions

During the Meeting of the Authors of Book on Distance Education in Asia in Surabaya, Indonesia last 3-4 July 2019, a task force, headed by Universitas Terbuka, was formed to produce a book on Distance Education. The Task Force member includes: Allama Iqbal Open University, University of the AAOU Annual Report 2018 | 29

Philippines Open University, Wawasan Open University, and Open University China. The Task Force is responsible for monitoring the progress of the book writing, including holding meetings (F2F and virtual). The President also reported that the Task Force already discussed the structure of the book and the goal is to have the book published during the AAOU Conference in October 2020 in Sri Lanka.

For the second initiative, another task force was formed consisting of the following: Universitas Terbuka, University of the Philippines Open University, Allama Iqbal Open University, Open University of Malaysia, and Cyber University of Korea. The meeting results to the formation of a post-graduate degree program namely, Master Program in Instructional Design and Technology that targets Teachers/Professional involved in instructional design both in distance education and technology enhanced residential education.

# 11 ELECTION OF THE AAOU PRESIDENT AND MEMBER OF THE EXECUTIVE COMMITTEE 2020-2022

The General Body were invited to note and approve the Election process of the AAOU President and Members of the Executive Committee CY 2020-2022 including the voting and counting of votes process as provided for by the AAOU Constitution as follows:

### ARTICLE VIII Section 1

- "(iv) The Secretary-General shall conduct the elections.
- (v) Voting for the President and other elected members of the Executive Committee shall be by secret ballot at the Annual General Meeting.
- (viii) The counting of the votes shall be conducted by the Secretary-General, with the ballot papers being opened and counted in the presence of two scrutineers approved by the Executive Committee."

In accordance with Article VII Section 1 (iv) of the AAOU Constitution, Secretary General, Dr. Grace Alfonso together with the two scrutineers approved by the Executive Committee — Dr. Zahid Majeed (Allama Iqbal Open University) and Dr. Prof. Mohammad Reza Zamani (Payame Noor Open University) — conducted the election.

The result of the election was announced by Dr. Zahid Majeed. The President, upon the suggestion of Prof. UI-Qayyum and Dr. Prof. Zamani, opened the nomination for one more member to constitute the Southeast Asia region of the Executive Committee, however, no nomination was received from the institutions present during the Meeting.

On behalf of The Open University of China, Mr. Shi Yunzhi, expressed an interest in continuing to serve in the AAOU Executive Committee. The General Body approved the proposal of OUC to be a co-opted

member of the Executive Committee 2020-2022. The President also mentioned that the Open University of Hong Kong also expressed their interest to be a member of the Executive Committee, however, there is still a need to reaffirm their intention as well as their official commitment to being a member of the Committee. Dr. Ul-Qayyum also proposed The Open University of Sri Lanka to be a co-opted member of the Executive Committee since the said institution will be hosting the 34th Annual Conference of the Association. The President then presented an option to have an election between the Open University of Hong Kong and The Open University of Sri Lanka. The results of the election are as follows:
